- 2. This includes any and all establishments throughout the State of Oklahoma. This list is not exhaustive and can be updated at any time. In accordance with AFMAN 44-197, para 1.2.2.1, any product containing hemp or hemp-derived products, including CBD, THC, and/or Marijuana is prohibited by all military personnel and can be violation of Article 92 and/or Article 112a, under Uniform Code of Military Justice.
- 3. This off-limits order prohibits military personnel from entering the above establishments to include the adjoining parking lots until further notice. Any military member who violates this order may be subject to disciplinary action under the Uniform Code of Military Justice.
- 4. I have placed these establishments off-limits due to activity that has endangered the good order, health, morale, safety, and welfare of military personnel. This order is made pursuant to AFI 31-213, Armed Forces Disciplinary Control Boards and Off-Installation Liaison and Operations.

5. This order will be briefed at all Commanders' Calls, FTEC classes, and all newcomer orientation briefings, as well as placed on all unit bulletin boards until such time as the order is rescinded.
