Know What Consent is and Get it!

Consent is a freely given agreement to the conduct at issue by a competent person." (DODD 6495.01)

Consent Looks Like:

- ✓ Communication honest, open, and continuous
- ✓ Changing one's mind at anytime
- ✓ Positive or Affirmative consent: "Yes" or "I am open to..."

Consent Does NOT Look Like:

- × Refusing to acknowledge no
- Someone being under the legal age of consent, as defined by the state
- Someone being incapacitated because of drugs or alcohol
- Pressuring someone into sexual activity by using fear or intimidation

Victims' Council

What Can Victims' Counsel do for Sexual Assault victims/survivors:

- Provide confidential legal advice
- Protect your rights and privacy interests
- Advocate your voice & choice
- Advise you on the investigation and prosecution process
- Represent you in interviews, hearings, and military trials

The CATCH Program gives people making a sexual assault report where the name of the suspect is not known by law enforcement an opportunity to anonymously submit suspect information to help the Department of Defense identify serial offenders.

Military Sexual Trauma (MST)

MST refers to sexual assault or sexual harassment experienced during military service.

The Vance AFB SAPR Office can direct survivors to on-base and community resources, as requested.
